
#### CYW Views

When children and youth come into care or when they change placements, there is the unfortunate opportunity to neglect the child's emotional needs regarding grief and loss. Whether the move was planned or unplanned, on good terms or on bad, there is a loss of connectedness from a place that was not always so turbulent.

When the children or youth move, often we find that they say fairly negative things about the last placement or about the move. It is easy to focus on 'how awful' the treatment was before they came. We find ourselves drawn to understand why they *needed* to move.

However, we need to keep in mind that regardless of the emotional presentation, these children and youth are experiencing grief and loss. Whether or not it is the loss of the parent/foster parent, family, community, peers, employment, school, animals, etc., there is a loss of connectedness which can bring about questions of belonging, issues of trust, and ability to disclose and build further relationships. When we understand the grieving process, we can look beyond presentation, empathize with the child, and respond in a way that may meet his or her needs much more therapeutically.
